RE: Delinquent Personal Property Taxes Removal

Tuscola County Treasurer Ashley Bennett provided each city, village, and township with a list of their delinquent personal property taxes that as of now the county does the collections for which includes doing 2 mailings per year for each delinquent personal property tax. She wants to clean up old delinquent personal property taxes that are still on the tax roll. She requested each local unit go through their list and determine which taxes may still be collectible and which are not. I have gone through the list for the City to determine which are uncollectible based upon if the business is still in existence or how old the tax is. I am requesting delinquent personal property taxes older than 7 years and the business is not in business any longer be removed.

Ashley has spoken with the county's attorney about going before the judge on behalf of the respective jurisdictions. and request removal of uncollectible taxes from the tax roll. He is willing to do this for a fee of approximately \$150 or less for each local unit.

Process:

The local unit will provide Tuscola County Treasurer Ashley Bennett with a list of uncollectible taxes. She will present the list to the attorney on their behalf. Next the attorney will take the list of delinquent personal property taxes before the judge and request that they be remove from the tax roll on behalf of each city, village or township. The judge will then grant or deny the request allowing Ashley to strike them from the roll and prevent further collection attempts.

Action:

Option 1: Approve the City Treasurer Michele Perry to provide Tuscola County Treasurer Ashley Bennett the list of uncollectible personal property taxes and request them go before a judge to be removed from the tax roll.

Option 2: Deny the City Treasurer Michele Perry to provide Tuscola County Treasurer Ashley Bennett the list of uncollectible personal property taxes and request them go before a judge to be removed from the tax roll.

Information from the County Treasurer's office:

They wanted to let us know that in the event local units do not take advantage of this opportunity and allow the county to clean up the tax roll, the County will be exploring other options for the maintenance of the delinquent personal property tax roll, which could include turning the duties and responsibilities of that tax roll back over to the local units. In that case, the County would no longer bill for or collect delinquent personal property taxes and it would be solely the responsibility of the township, village, or city to collect those taxes.

I recently attended a webinar regarding the NEW SPARK GRANT program with City Treasurer, Michele Perry. Upon completion we took the necessary steps to create accounts for the pre application process. Upon completion of those steps, we were made aware of the need for a resolution to be passed for the 5 Year Parks & Recreation Plan. The Council has made the required resolution.

Following the initial steps, I discussed the grant with Parks & Recreation Chairman, Sean Smith. After reviewing the grant details, we found it to be a good fit for the City of Caro Parks and Recreation department. The Parks and Recreation Committee has been working to ensure the Park Plan is a living document by creating a timeline for the recommended projects which are data driven and follow the over all timeline of the projects outlined in the plan. I presented the SPARK GRANT Program to the Parks and Recreation committee at the November meeting. The committee moved to recommend to council that the application process begin with the additional support of a Parks and Recreation subcommittee.

Additionally, the City of Caro Council has moved to support the use of funds to begin the renovation process of the Mertz Road building and create a permanent Park and Recreation facility. This aligns well with both the timing of and the objectives of the SPARK GRANT. The initial application is due in mid-December, and the committee will meet to provide input and assist with the completion of the application prior to approval of Council and submittal. The grant does not require a match and covers costs for project planning as of October 1st,2022. Design and planning is necessary to complete the process.

Recommendation:

I recommend the City Council move to accept the recommendation of the Parks & Recreation Committee and support the Spark Grant Application process to begin immediately.

The City of Caro was presented with several previously designed preliminary plans for the municipal parking lot to be constructed adjacent to the City Hall Municipal Building located at 317 South State Street, Caro, MI 48723 at the November 9th Council meeting. At that time the Council moved to request a Design Engineering Services Proposal from Rowe Engineering. Attached you will find the full agreement for services and proposal.

This project has been budgeted for the 2022 fiscal year. The preliminary design plan was created prior to the purchase and demolition of the structures previously adjacent to the City Hall Municipal Building. Since those conceptual designs, the City has made significant progress with this project, including the purchase of the land, the demolition of the structures, and the topographical study. Additionally, the City of Caro Planning Commission and the City Council have made suggestions for features related to the design to Rowe Engineering in public meetings.

Contract for Engineering Services
City Hall Parking Lot Project
City of Caro, MI

THIS AGREEMENT, entered into this _____ day of _____, by and between the City of Caro hereinafter referred to as the "OWNER", and ROWE Professional Services Company, hereinafter referred to as the "ENGINEER".

WITNESSETH, that whereas it is the intent of the Owner to complete the following, hereinafter called the "PROJECT": Design Engineering for a new municipal parking lot adjacent to City Hall.

NOW, THEREFORE, the OWNER and the ENGINEER, in consideration of the mutual covenants hereinafter set forth, agree as follows:

SECTION 1 – BASIC SERVICES OF THE ENGINEER

A. General:

1. The Engineer agrees to perform professional services in connection with the Project as hereinafter stated.
2. The Engineer will serve as the Owner's professional representative for the project, and will give consultation and advice to the Owner during the performance of the Engineer's services.

B. Scope of Service:

After written authorization to proceed with the project, the Engineer will execute the work plan described in the Engineer's Proposal, dated November 16, 2022.

SECTION 2 – ADDITIONAL SERVICES OF THE ENGINEER

A. General:

If authorized in writing by the Owner, the Engineer will finish or obtain from others additional services of the following types which will be paid for by the Owner as indicated in Paragraph 5.B.

1. Additional services due to significant changes in general scope of the Project or its design.
2. Additional services in connection with the Project, not otherwise provided for in this agreement, subject to prior approval of the Owner.

SECTION 3 – THE OWNER'S RESPONSIBILITIES

1. Provide full information as to its requirements for the Project.
2. Assist the Engineer by placing at the Engineer's disposal all available information pertinent to the site of the Project, including previous reports and any other data relative to design and construction of the Project.
3. Provide access for the Engineer to enter upon lands as required for the Engineer to perform work under this Agreement.
4. Examine all studies, reports, sketches, estimates, specifications, drawings, proposals and other documents presented by the Engineer and shall render in writing decisions pertaining thereto within a reasonable time so as not to delay the work of the Engineer.
5. Provide reasonable legal, accounting and insurance counseling service for the Project.
6. Designate a person to act as the Owner's representative with respect to the work to be performed under this Agreement. Such person shall have complete authority to transmit instructions, receive information, interpret and define Owner's policies and decisions with respect to material, equipment elements and systems pertinent to the work covered by this Agreement.

7. Give prompt notice to the Engineer whenever the Owner observes or otherwise becomes aware of any defect in the project.
8. Obtain approval of governmental authorities having jurisdiction over the Project.
9. Furnish, or direct the Engineer to provide, at the Owner's expense, necessary additional services as stipulated in Section 2 of this Agreement, or other services as required.

SECTION 4 – PERIOD OF SERVICE

1. Upon written authorization from the Owner, the Engineer will proceed with the performance of the service called for in this Agreement.
2. Unless sooner terminated as provided in Paragraph 6.A, this Agreement shall remain in force for a period which may reasonably be required for completion of the construction of the proposed project; however, not greater than one year from the Engineer's substantial completion of the phases of work that have been authorized for commencement.

SECTION 5 – PAYMENTS TO THE ENGINEER

A. Payments for Basic Service of the Engineer Under Section 1:

1. The Owner will pay the Engineer for basic services \$27,200.00.
2. The fee as defined above shall be allocated to be paid monthly, as the work progresses.

B. Payment for Additional Services of the Engineer Under Section 2:

1. The Owner will pay the Engineer for additional service at a mutually agreed upon fee.

C. General

1. If this Agreement is terminated upon completion of any phase of the Engineer's services, the progress payments to be made in accordance with Paragraph 5.A.1 and 5.A.2 on account of all prior phases shall constitute total payment for services rendered; if terminated during any phase of the work not due to any fault of the Engineer, payment shall be made for services performed during such phases on the basis of the portion of each phase completed prior to termination.
2. If, prior to termination of this Agreement, any work designed or specified by the Engineer during any phase of the work is suspended in whole or in part or abandoned not due to any fault of the Engineer, after written notice from the Owner, the Engineer shall be paid for services performed prior to receipt of such notice from the Owner as provided in Paragraph 6.A for termination during any phase of the work.
3. Where the Engineer utilizes subcontractors to perform a portion of the project, and the subcontractor(s) directly invoices the Engineer, the subconsultant's invoices will be marked up by fifteen percent to cover administration costs.

SECTION 6 – GENERAL CONDITIONS

A. Termination:

This Agreement may be terminated by either party by fourteen (14) days written notice in the event of substantial failure to perform, in accordance with terms hereof, by the other party through no fault of the terminating party. If this Agreement is so terminated, the Engineer shall be paid as provided in Paragraph 5.C.

B. Ownership:

All documents, except original drawings, but including estimates, specifications, field notes and data are and remain in the property of the Engineer as Instruments of Service. The Owner shall be provided a set of reproducible drawings and copies of other record documents. However, they are not intended or represented to be suitable for re-use by the Owner or others for extensions of the project or for any other project.

C. Insurance – Save Harmless:

The Engineer shall secure and maintain such insurance as will protect the Engineer and the Owner from claims under the Workman's Compensation Acts and from claims for bodily injury, death or property damage which may rise due to the Engineer's negligence in the performance of services under this Agreement.

D. Successors & Assigns:

The Owner and the Engineer each binds themselves and any partners, successors, executors, administrators and assigns to the other party of this Agreement and to the partners, successors, executors, administrators and assigns of such other party, in respect to all covenants of this Agreement; except as above, neither the Owner nor the Engineer shall assign, sublet or transfer their interests in this Agreement without the written consent of the other. Nothing herein shall be construed as creating any personal liability on the part of any officer or agent of any public body which may be a party hereto.

E. Independent Contractor:

It is understood and agreed that the Engineer is an independent contractor, responsible to the Owner for the results of this undertaking by the Engineer and is not an employee or agent of the Owner.

F. Non-Discrimination:

The Engineer and/or any sub-contractors shall not discriminate against any employees or applicant for employment, or to be employed in the performance of his Contract with respect to his or her hire, tenure, terms, conditions or privileges of employment, or any matter directly or indirectly related to employment because of race, color, religion, national origin or ancestry.

The Engineer and/or any sub-contractor shall not discriminate against any employee or applicant for employment to be employed in the performance of this Contract with respect to his hire, tenure, terms, conditions or privileges of employment, because of age or sex, except where based on a bona fide occupational qualification.

G. Mediation:

In an effort to resolve any conflicts that arise during the design and construction of the project or following the completion of the project, the Owner and the Engineer agree that all disputes between them arising out of or relating to this Agreement or the project shall be submitted to nonbinding mediation unless the parties mutually agree otherwise.

The Owner and the Engineer further agree to include a similar mediation provision in all agreements with independent contractors and consultants retained for the project and to require all independent contractors and consultants also to include a similar mediation provision in all agreements with their subcontractors, sub-consultants, suppliers and fabricators, thereby providing for mediation as the primary method for dispute resolution between the parties to all those agreements.

H. Jobsite Safety:

Neither the professional activities of the Engineer, nor the presence of the Engineer or its employees and subconsultants at a construction/project site, shall relieve the General Contractor of its obligations, duties and responsibilities including, but not limited to, construction means, methods, sequence, techniques or procedures necessary for performing, superintending and coordinating the work in accordance with the contract documents and any health or safety precautions required by any regulatory agencies. The Engineer and its personnel have no authority to exercise any control over any construction contractor or its employees in connection with their work or any health or safety programs or procedures. The Owner agrees to require the General Contractor(s) to provide liability insurance for the project(s), indemnifying and listing as additional insureds the Owner, the Engineer and the Engineer's subconsultants.

I. Limitation of Liability:

In recognition of the relative risks and benefits of the project to both the Owner and the Engineer, the risks have been allocated such that the Owner agrees, to the fullest extent permitted by law, to limit the liability of the Engineer to the Owner for any and all claims, losses, costs, damages of any nature whatsoever or claims expenses from any cause or causes including attorney's fees and costs and expert-witness fees and costs, so

that the total aggregate liability of the Engineer to the Owner shall not exceed \$27,200.00, or the Engineer's total fee for services rendered on this project, whichever is greater. It is intended that this limitation apply to any and all liability or cause of action however alleged or arising, unless otherwise prohibited by law.

J. Standard of Care:

The Owner recognized that the engineering services require decisions which are not based upon pure science but rather upon judgmental considerations, including the economic feasibility of alternative designs. The Engineer shall perform its services in accordance with generally accepted engineering practices. Services are rendered without any other warranty, express or implied and the Engineer shall be responsible solely for its own negligence.

K. Construction Costs:

The Owner shall advise the Engineer in writing before design commencement of any budgetary limitation for the overall cost of construction. The Engineer will endeavor to work within such limitations and will, if requested and included within the scope of services, submit to the Owner an opinion of probable construction cost. Opinions of probable construction cost will represent the Engineer's best judgment as a design professional familiar with the construction industry but does not represent that bids or negotiated prices will not vary from budgets or opinions of probable cost. Owner acknowledges that neither the Engineer nor the Owner has control over the cost of labor, materials or methods by which contractors determine the prices for construction.

L. Applicable State Law:

This document shall be governed by the laws of the State of Michigan.

SECTION 7 – SPECIAL PROVISIONS

The Owner and the Engineer mutually agree that this Agreement shall be subject to the following special provisions which, together with the provisions hereof and the exhibits hereto represent the entire Agreement between the Owner and the Engineer and that; they may only be altered or repealed by a duly executed written instrument.

- Attended the City Council meeting on October 17, 2022 & November 9, 2022.
- Update on CDBG funding related to the Farmer’s Market pavilion:
 - Former Mayor Greene, Interim City Manager Lauren, Mike Carpenter and Kim Carter (grant writer) have had a couple of Teams meetings with Lenore from MEDC to finalize the grant. We may receive approximately \$32,000 out of \$40,000 for construction engineering. The decision is currently in the hands of Lenore at MEDC.
- Attended a MMTA UP webinar on November 3, 2022. Highlights from the webinar were as follows:
 - Short term rental is still be discussed at the legislation and there has been talk that this will be passed during the lame duck session. Short term rentals have to be treated as residential property and not commercial. There is a limit of 30% of available housing.
 - The blight elimination program which I presented at the last meeting.
- Blight elimination program status. After the November 9, 2022 council meeting I contacted the Tuscola County Land Bank and spoke with Steve Erickson & Jim McLoskey. I sent Steve various links to the program and he has spoken with other Tuscola Land Bank board members regarding the program. They are having a Zoom meeting on November 28th with the State Land Bank Authority to discuss the proper procedure to go about writing for the grant and administrative questions related to the program. After that meeting the Tuscola Land Bank will be having a meeting and have invited Mayor Snider and I to attend so we are informed on how the program will be done.
- I attended a webinar regarding the Michigan DNR Spark Grants. Durning the webinar for the grant there was a discussion regarding 3 things that an entity has to have to apply and they are:
 - Sigma vendor number
 - Federal UEI number from SAM.gov
 - The entity be registered with DNR’s grant system
 - I made sure we had all of the above items which we do now. I the process of updating the registration for the DNR’s grant system it was brought to my attention by the DNR that the Parks and Recreation 5 year plan was not approved by the DNR. There were two items missing for it to be approved one being a picture of the LWCF plaque for Beith Park which I located a took a picture to forward to the DNR. The other item was the resolution from the to approve the 5 year plan which Rita had the council do at the November 9th meeting.

I forwarded the resolution to the DNR on Wednesday. The 5 year plan is now approved and we are eligible to submit for DNR grants.

- The grants can be used for any recreational project and the requestor defines recreation.
- The minimum grant is \$100,000 and the maximum grant is \$1,000,000. Eligible matching funds are encouraged but are not required and will not be considered as part of the application scoring. Federal funds are not eligible sources of matching funds.
- There are 3 rounds of applications and the first round of applications are due on December 19, 2022 and will be awarded in January of 2023. Rounds 2 and 3 applications deadlines are to be determined.
- 3 applications can be submitted for 3 different projects.
- On November 16, 2022 attended the audit wrap up meeting with Jamie Peasley (auditor) and Interim City Manager Lauren
- Attended the DDA meeting on November 9, 2022 and reviewed the financial statement with them and also spoke about the Blight Elimination Program.
- The Treasurer's Office has been very busy over the last month with the following items:
 - Collecting Summer taxes of which as of 11/17/22 95% have been collected.
 - Collecting utility payments
 - Mailing out bill payments
 - Receiving and tracking responses from residences regarding the way in which they are opting to pay for the sidewalk invoices for the sidewalk projects from 2021 completed in spring of 2022.
 - Mailing out 281 ten day letters for utility bills
 - Producing 79 tags for delinquent utility bills
 - 14 water shut offs for non-payment of utility bills
 - Mailing reminder to residents who have not paid their summer tax bills.
 - Preparing items for the County treasurer so they can send the winter tax bills to KCI to be printed and mailed.
- Presented at the council meeting is a list of delinquent personal property taxes which need to be removed from the tax roll due to the business no longer in existence or over 7 years old.
- I contacted Dave's Glass and Bay Glass Co. to get quotes on changing the side entry door into a ADA accessible door.
- Assisted in covering the front desk during staff lunches and vacations.
- Continued to work on changing the chart of accounts to the new Michigan Department of Treasury Uniform Chart of Accounts for Local Units of Government which the recommended implementation date is July 1, 2022, but not later than June 30, 2023.
