RE: Agenda Item – Repair and Painting of Tanks at Water Treatment Facility

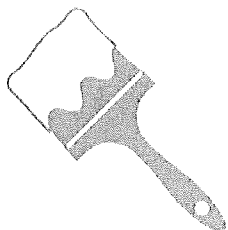
Members of the Caro City Council,

As you are aware, we are in the process of replacing the filter media at the water treatment facility, as part of the replacement process once the media was removed it was determined the inside of the treatment tanks was in poor condition and required repair and repainting before the new media was installed to ensure a long service life. As such, quotes were obtained and it was recommended by DPW Superintendent Reese, with my concurrence, to retain the services of Crystal Coatings Inc to repair and paint the interior and exterior of both tanks, his estimated cost is \$203,000.00.

In the Fiscal Year 2023/2024 budget, we anticipated spending \$100,000 to paint the exterior of the tanks, therefore, in order to have enough budgeted for this project an adjustment is required.

Your option for motions is:

1. Motion to authorize the City Manager to award the water tank painting job to Crystal Coatings Inc. at a cost of \$203,000.00, and to adjust the FY 2023/2024 budget by increasing account number 592-557-801-000, Contracted Services, by \$103,000.00, decreasing account number 592-557-999-001, Transfer to Fund Balance, by \$58,160.00, and transferring \$44,840.00 from the Water Fund Balance.

Quote for 2 pressure filter vessels interior and exterior. ...Scope of work interior..... upper chambers of interior will be sandblasted removing all loose coatings and rust leaving a 2-3 mill profile on substrate then all of the sand and debris will be vacuumed out. coatings..... all sandblasted steel will be coated with tnemec series 22 nsf approved epoxy achieving 20 to 24 mills dft prior to spraying all welds will be stripe coated with tnemec series 22 all nozzle holes will be protected before coating starts..... chamber under nozzle floor will be inspected and spot cleaned were needed and coated.... Exterior scope of work. Exterior will be pressure washed using a 4000 psi machine then all of the exterior surface will be machine sanded leaving a profile and all heavy rust will be ground leaving a feathered edge. Exterior coatings.all bare metal will be primed with tnemec series 135 epoxy then 1 full coat of tnemec series 135 epoxy will be applied to the whole exterior. then 1 full coat of tnemec series 1074 polyurethane will be applied color to be chosen by owner.
