Now that the holiday season is wrapping up and new year resolutions are being set for 2023, I wish everyone a prosperous new year.

Winter tax bills were mailed out on December 1, 2022, if you have not received yours yet, please stop by City Hall and we can reprint it for you. Winter and summer property taxes are collected at City Hall through February 28, 2023, then starting on March 1, 2023, they would have to be paid at the County Treasurer's Office. There is a drop box outside City Hall which property tax payments can be put in.

Property tax assessments will be mailed out during February 2023. The March Board of Review will meet to hear property owners on the 3rd Monday in March which is March 20, 2023.

Business owners with personal property please read the information below:

- 1. If you have personal property valued less than \$80,000 you need to complete Michigan Treasury Form 5076 (if you have not already) to be exempt from personal property taxes. This is a one-time filing requirement. The form is due to the City of Caro no later than February 20th.
- 2. To claim an exemption for personal property valued at \$80,000 or more but less than \$180,000, Michigan Treasury Form 5076 along with Form 632 Personal Property Statement MUST be filed ANNUALLY with the City of Caro where the personal property is located no later than February 20th each year.

The staff at the DPW hope you had an enjoyable holiday season. It has been a slow start to winter with snow and ice, but I would like to remind everyone that there is no parking on any city street from 2-5 am through March.

Along with the State of Michigan, the City of Caro has an ordinance that does not allow shoveling, plowing, or blowing of your snow into the streets. Please be considerate when you see any city, local or state plowing trucks on the roads giving them much needed space and remembering that they might not be able to see you.

Bad Stuff Happens in the Bathroom

It is not always pleasant to talk about what happens in the bathroom. But when we do talk about what is being flushed or poured down the drains, we are working together to ensure that there is no excessive wear and tear on the pumps and other wastewater treatment equipment.

Please do not flush items like, feminine hygiene products, diapers, paper (other than toilet paper) or adult/baby wipes. Do not pour items like grease, food scraps, or paint down the drains. When theses items go down the drains, they do not dissolve in water and create blockages in sewer lines and the pumps at the Wastewater Treatment Plant.

Caro Fire Department Randy Heckroth

The City of Caro Fire Department will soon be offering Medical First Responders to assist MMR with Priority One medical calls. Approximately half the department has enrolled in the training. We forecast that sometime in late January we will be able to offer this level of community service to all our primary service areas. This will include all the City of Caro, all sections of Indianfields Township. . a section of Wells Township, Ellington Township, Juniata Township and Almer Township.

Fortunately, this department has a City Council, City Manager, and Township Supervisors that believe in funding the department with whatever it takes for tools, equipment, and training. The Fire Fighters are then able respond to such calls with the best available equipment, thus providing the best response anyone could offer.

Another project that is due to be finished in 2022 will be the activation of our new Emergency Response trailer. The trailer will deliver to a scene equipment for Water rescue, Grain Bin rescue, and mass casualty rescue. It will also include a command post in the front equipment used for missing persons and any type of a natural disaster, such as a tornado.

Always check your smoke and carbon monoxide detectors, State laws and City ordinances mandate the use of smoke detectors in every residential household.



City offices will be closed Monday, January 16, 2023 in observance of Martin Luther King, Jr. Day Please call 989-673-2226 to receive your free burn permit, valid for 30-days

- Please leave your name, contact #, and the address where you will be burning
- Permits are valid for out of City residence only, if you reside within the city limits of Caro, please leave your name and number. The Fire Chief will contact you, to give instructions for allowable fires within the city.
- The State of Michigan only allows tree limbs and natural logs to be burnt
- No garbage [even if in a container] may be burnt at any time
- It is illegal to burn tires, pallets, or any type of construction material
- All fires must be in attendance of a capable adult at all times
- No fires shall be lit under and type of tree or electrical power line



Winter is a beautiful time of the year. With falling snow, comes the dangers of slipping and falling.

Please remember, it is the responsibility of homeowners to keep your sidewalks and walkways clear of snow and ice.

Also consider, keeping the area around the fire hydrants clean of snow and ice. In case of an emergency, this will help the firefighters access the hydrant.

Code Enforcement Department Randy Heckroth

The Code Enforcement Officer would like to thank everyone for their efforts in keeping our city clean this past summer. Although there is still work to be done, it looks great.

Please check your yards for any items that may need to be stored inside for the winter months. Remember, anything left laying out will be there come spring and possibly damaged. Please check your house and garages for any type of structure damage that could become worse when ice and snow get into it. Check for any holes that critters may try to enter to stay warm.

Please be aware that there is an ordinance that does not allow any parking on the streets during the months of December, January, February, and March. This will allow the City DPW workers a chance to insure proper snow removal from the streets. A reminder that no one should park across or on a sidewalk, this is a safety issue. Parking there may force a person to walk around and onto a street were vehicles are in motion, causing an unsafe act. There is no parking on the city right of way, which is between the curb of the street and the sidewalk.

Please ensure that your sidewalks are kept clean of any ice and snow. The ordinance states this should be accomplished no later than 10 am of each day. Failure to do so may cause city workers to perform the task at the expense of the property owner. This again is for the safety of our residents, and to insure a safe passage for your mail delivery.

A Smart911 Safety Profile delivers critical caller data with incoming 9-1-1 calls. It helps 9-1-1 call takers make faster and better decisions, shortens response times, and helps save lives.

Residents sign up for Smart9ll and enter information they want 9-l-l to receive in case of an emergency. Information can include family member data, photos, medical conditions, disabilities, mobility limitations, exact addresses, even pets. Data is automatically validated against user's phone number(s) and citizen provided data is kept fresh through a patented aging process.

When a person calls 9-1-1, their data automatically displays on the 9-1-1 call taker's workstation, providing additional information that helps to dispatch the best response to the right location. Data can be easily pushed to responding Law Enforcement, Fire, and EMS to help them respond more quickly and effectively.
