The City of Caro Clerk's Office has been busy preparing for the upcoming changes for all future Michigan Elections. My newsletter will highlight all the new changes and pertinent information that every voter should know. As always, I am available for questions via email, phone and/or in person. This information will be posted on our website and Facebook page for reference. Due to the passing of Proposal 22-2 in the November 2022 Election, Michigan elections will look different. Here are explanations of each voting method:

l. Absentee

- Any registered voter can vote with an absentee ballot. There are 2 steps to this process: 1 - Submit a ballot application (unless you have previously submitted a permanent ballot application). 2 - Return your voted ballot by mail, absentee ballot drop box or in person during clerk's office hours. Absentee Ballots Due: 8:00 p.m. Election Day
- 2. Permanent Absentee
- Voters who want to automatically be mailed a ballot for all future elections may sign up for the Permanent Absentee Voter Ballot List anytime at www.Mi.gov/Vote or when submitting an Absentee Voter Ballot Application.
- 3. In Person Election Day
  - Voters will have the option to vote in person on Election Day from the hours of 7:00 a.m. to 8:00 p.m. at the City of Caro Municipal Building.

Permanent Absentee Ballot List Voters (voters who receive ballots automatically)

All Permanent Ballot List voters will receive a Presidential Primary Ballot Selection Form in the mail. Ballot preference must be selected and returned to the clerk's office by February 7, 2024. If you do not return your Presidential Primary Ballot Section Form, you will receive a ballot with proposals only.

Absentee Voter Ballot Application List Voters (voters not currently on the Permanent Ballot List)

All Absentee Voter Ballot Application List voters will receive an Absentee Voter Ballot Application in the mail. Election dates, ballot preference, and option to be placed on the Permanent Ballot List shall be selected and returned to the clerk's office in a timely manner. \*\*NEW\*\* Absentee Voter Ballot Processing Election Day

Absentee voters may bring in their ballot on election day and run it through the tabulator.

Register to Vote Options (or Updating Address):

- Those who have a valid Michigan Driver's License or State ID, can register at www.MI.gov/Vote.
- Register by mail: Applications are available on the City of Caro website, <u>www.carocity.net</u>.
- Register in person at the Clerk's office.

Voter Registration Deadlines:

- Online or by mail up to 15 days before election.
- In person at the Clerk's office: Through election day (proof of residency required during last 14 days before election day)

2024 Elections

Special Election – May 7, 2024 (no 9 days early voting) Primary Election – August 6, 2024 General Election – November 5, 2024

Precinct Change & Polling Location

The City of Caro no longer has 2 precincts. All voters in the City of Caro are now in Precinct I. Those voters affected should have received a new voter ID card from the Clerk's office. Polling location for Precinct 1 will be the City of Caro Fire Hall Training Room, 317 S. State St., Caro, MI 48723. Please enter the building on the east side and follow the appropriate signage.

#### Department of Public Works Tom Reese

Spring is in the air!! In April, the Department of Public Works will be out jetting sanitary sewer for maintenance. In May we will start chipping brush remember that chipping is done on the first Monday in May (6th), third Monday in July (15th), third Monday in August (19th), and first Monday in October (7th). The DPW will pick up piles of brush up to six (6) feet wide and four (4) feet high by six (6) feet long. Brush is to be placed at the curbside no more than ten (10) days prior to the next pickup and it must contain branches less than 4 inches in diameter. When branches are placed at the curb, place the cut end toward the road edge and stack them neatly. The City will not pick-up whole trees or large amounts of brush. You may want to consider a private contractor to remove trees or larger brush piles. In addition, the City dump located on Weeden Road will be opened from 10 a.m. to 12 noon the first and third Saturday starting in April and ending the last Saturday in November.

Our Community Cleanup will be on Saturday, May 4, 2024 from 8 am to 1 pm, by the tennis courts at Bieth Park. Further information is available in this newsletter.

#### Caro Fire Department Randall Heckroth

With spring right around the corner, and yard clean up near--please be mindful of the burning laws in the State of Michigan and within the City limits of Caro.

For burn permits outside the Caro City limits, please contact the fire station at 989-673-2002. You will hear a message concerning the rules and regulations for the State of Michigan. Permits are valid for 30 days. Anyone that would like to have a camp fire within the City limits, in an approved container, please leave your name and number. The Fire Chief will contact you, with specific rules for within the City limits. Please remember that the state only allows the burning of tree branches and logs. No garbage, and no lumber of any type, anywhere in the state.

Please contact the Fire Chief or a Firefighter for all your fire safety related questions.

## Siren Testing

Weather sirens are strategically placed throughout the community so that they are heard if severe weather is approaching. If the sirens are activated, be sure to seek cover and if possible have a radio or television near your shelter to listen for current weather conditions.

Caro Fire Department activates the cities weather sirens, testing them on the first Wednesday of April through October at 10 am. The siren sounds, first for severe weather and the second for citizens' security.

When the sirens activate, they will sound for 3 minutes. When there is a real threat, the sirens sound at the moment the NWS issues the warning and the sirens sound for 2 minutes, then 8 minutes later they are set off again. This continues every 10 minutes until the warning expires set by the NWS.


